1. INTRODUCTION

Therefore, these academic institutions agree to establish a programme for academic cooperation in the activities run by the Physical Education and Sports and in accordance with the terms and conditions set out in this MOU.

2. THE OBJECTIVE

Maharashtra Udayagiri Mahavidyalaya, Udgir has taken an initiative of bringing the Physical Education and Sports of the participating institutions together for the purpose of cooperation, promotion and networking of Physical Education and Sports of respective colleges to provide academic and sports facilities to the students / sportsperson of the college the entire exercise aims at:

- Preparing the students for appearing various state, national and international event of sports.
- Providing guidance to the students from rural background for participating in various sports
 event.
- Creating awareness among the students for various sport competitions at State, National and International level.

3. THE AUTHORITY

The MOU will primarily governed by the respective Principal of the colleges in their campuses. The Director of Physical Education will be the authority to represent and express the college. The collective decisions made will be implemented by Director of Physical Education.

4. ACTIVITIES

- 1. Co-operation in research activities and development projects in the fields of Physical Education and Sports.
- Co-operation in academic activity and training in the fields of Physical Education and Sports.
- 3. Jointly organize symposia, conferences, workshop, seminars, webinar and faculty/staff development programmes in the fields of Physical Education and Sports,
- 4. Jointly organize academic courses and programs in the fields of Physical Education and Sports.
- 5. Joint publications of scientific and educational research in the fields of Physical Education and Sports.
- 6. Jointly Organizing various sports competitions.
- 7. To exchange the facilities required for organizing the competition
- 8. Other mutually agreeable undertakings

5. TERMS AND CONDITIONS:

- This MOU will take effect from the date it is signed by the Principal and Director of Physical Education of the participating institutions. It will remain valid for a period of five years (2019-2025) and may be continued thereafter after suitable review and agreement.
- This MOU may, at any time during its period of validity, be terminated by one of the participating institutions upon prior notice to the other in writing not later than six months before the termination date. Once terminated, no other institution will be responsible for any losses, financial or otherwise, which the other institutions may suffer.
- The expenditure incurred for conducting various activities will be borne by respective colleges.
- This MOU may only be amended or modified by a written agreement signed by the representatives of each participating institution.
- If there would be a dispute relating to any aspect of academic cooperation, the Principal or the Director of Physical Education of participating institutions will jointly resolve the dispute in a spirit of independence, mutual respect and shared responsibility.
