 Development of joint research projects and publications (All joint activities will be carried through the mutual agreement and clearly established conditions)

TERMS AND CONDITIONS: The MoU would be executed under the following (and not restricted to) the general guidelines:

- A specific plan for any activity will be worked out depending upon the availability of resources.
- 2. A specific agreement will be entered into for each activity.
- The financial arrangements wherever involved will be decided and approved after mutual consent and shall be agreed to for each activity individually.
- Both entities agree to help, identify and invite students, teachers and researchers to participate in conferences, workshops and other such activities.
- 5. Any intellectual Property Rights work that may arise as a result of joint research and collaborative activity under the agreement will be worked out on a case to case basis.
- 6. Changes to this agreement shall be made by mutual consent between both institutions.
- Both entities will designate nodal contacts (persons who will have responsibility) for implementation of this agreement.
